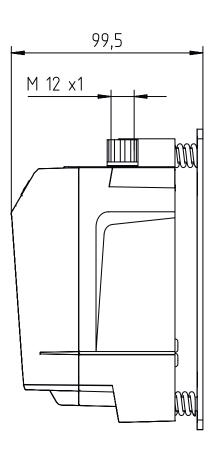

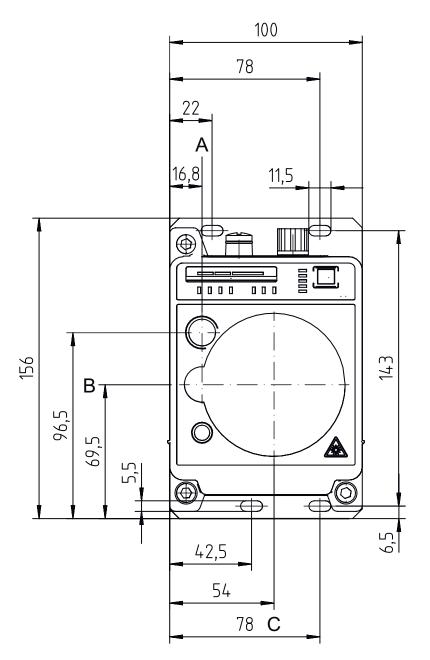

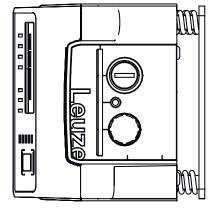

C Center axis of receiver

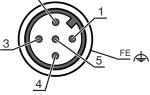

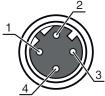

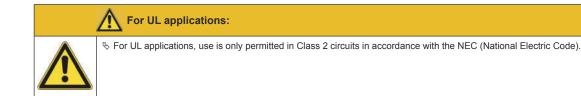
